The race begins near the Pearl Street entrance of mBank and proceeds through town, under the bridge, past the Manistique Marina, east on US-2 (10K continues on to turnaround on Glenwood Drive), and returns via the Lake Michigan boardwalk, finishing at the Manistique Marina. The walk/race is part of Manistique's Folk Fest weekend celebration and is sponsored by Manistique Papers.

THE START
